Centre may push Aadhaar legislation as money bill

Though the government is yet to finalize its stand whether to get the same bill passed or to move new amendments, there is strong indication that the Centre may push the legislation as a money bill in the coming session to ensure that a logjam in Parliament does not block its JAM initiative. A money bill can't be blocked in Rajya Sabha where the ruling dispensation lacks numbers.

The Aadhaar (Delivery of Benefits, Subsidies and Services) Bill 2016, which is likely to replace pending NIDAI Bill, could help the government counter concerns raised about issue of privacy and data security. The fresh legislation provides for proof of Aadhaar number as a condition for receipt of benefit and subsidy funded by the consolidated fund of India.

The attorney general has given his opinion that the new bill can be introduced as a money bill as per Article 109 & 110 of the Constitution.

The new bill has more stringent measures such as prohibition on sharing of core biometric information and setting up of an oversight committee to monitor disclosure of information under the Act.

It also suggests that biometric information under Aadhaar would be considered as sensitive personal information as per Information Technology Act. The definition of 'resident' has been modified to include a person who is resident in India within the meaning of section 6 (1) of the Income Tax Act to avoid ambiguity. As the last option, the AG has suggested that the government may make rules under existing Information Technology Act to address the concerns around Aadhaar
