Subject: Query in relation to periodic/event base submission/Non-Submission of SDD Non-Compliance by the Company.

Reference: Trade Wings Limited (Scrip Code: 509953)

With reference to the above, we would like to humbly state as under:

- The Company has received below mentioned query on email dated 24.01.2024 pertaining to periodic/event base submission/Non-Submission of SDD Non-Compliance through communication module on BSE.
  - "Dear Sir/Madam, this is with reference to the intimations given by the Exchanges to the company, continuous reminders in the said matter of non-compliance related to maintenance of Structured Digital Database (SDD). It has been observed that till date the Company is still non-compliant with provisions of Reg. 3(5) and/or Reg. 3(6) of SEBI (Prohibition of Insider Trading) Regulations, 2015 as per the certifications provided/Exchange Verification of compliances/Non-submission of required certification. Accordingly, the stock reach page on the Exchange website continues to display the non-compliance status. The company is once again advised to provide SDD Compliance status latest by February 22, 2024 and timeline within which the company shall be fully compliant with SDD requirements, if not compliant till date. It may be noted that non-compliance will be viewed seriously and liable for enforcement action under the extant legal framework. You are requested to take note of the above and report compliance".
- 2. The stock reach page of the Company still shows "SDD Non-Compliant" after complying with the SDD compliance.
- 3. Further, the Board of directors of the Company hereby confirms that the Company has internally complied with the regulations and also that a database maintained by the Company is password protected and is stored on a computer which is password protected.

- 4. Also, the Company has duly complied with the SDD Compliance Certificate for the quarter ended December 2023 and uploaded requisite compliance certificate on the BSE Portal.
- 5. In view of the above please find enclosed herewith the status of SDD Compliance in tabular format along with its acknowledgement for easy reference. (Annexure A)
- 6. Please clarify on the said matter as the Company is unable to identify the default raised in the query by BSE as the requisite filings has been already done. We would request you to contact on undersigned for any further explanation in this regard.

We request you to take the above submission/comments on record and condone the delay which was caused due to inadvertence and with no malafide intentions. We assure of timely compliance of law in spirit.
